

## Ergobaby Metro+ Cashback Promotion

Buy an Ergobaby baby carrier\* on special offer and an Ergobaby Metro+ stroller within the promotional period and claim up to £60 cashback or 75 EUR \*.

- **Promotion period\***

The Ergobaby Metro+ stroller Cashback promotion period runs **from 01.01.2021 to 31.10.2021**. The baby carrier on special offer and Metro+ stroller can be purchased together or separately. To be eligible for the promotion, the invoice date for both the baby carrier on special offer and the Metro+ stroller must fall within the period specified above.

- **Baby carriers on special offer\***

All Ergobaby baby carriers on special offer are eligible for the cashback promotion. The following products fall under the term “baby carriers on special offer”:

- Ergobaby Adapt
- Ergobaby Omni
- Ergobaby Aerloom

- **Cashback amount\***

The cashback amount depends on the model of the baby carrier on special offer. The following list shows the cashback amount for the selected models of baby carriers on special offer:

- Metro+ Stroller and Embrace Baby Carrier = 30 EUR Cashback
- Metro+ Stroller and Adapt Baby Carrier = 40 EUR Cashback
- Metro+ Stroller and Omni Baby Carrier = 50 EUR Cashback
- Metro+ Stroller and Aerloom Baby Carrier = 75 EUR Cashback

In British Pounds:

It is irrelevant whether the articles were purchased from the same or different retailers. This means that the baby carrier on special offer and Metro+ stroller can be purchased together or separately.

### **1. Submission of product and customer data through a dedicated promotion site by 19.11.2021**

- In order to qualify for the cashback, you will need to register on our dedicated promotion site [www.ergobaby.portica.com](http://www.ergobaby.portica.com). The registration process requires you to enter all the information relevant to your participation in the cashback promotion and upload copies of the related invoice documents. If you did not purchase the items at the same time, please upload both receipts separately in the designated sections.
- Closing date: In order to be eligible for the cashback, the required information and relevant documents must be uploaded to the aforementioned promotion site by 19.11.2021.

### **2. Cashback payout**

- The cashback will be paid out by the promotion service provider (PORTICA GmbH Marketing Support).
- Following the submission of all required documents, the promotion service provider will pay out the cashback within 4 weeks through bank transfer using the provided bank details.
- The cashback includes any applicable VAT. Cashback payout in cash is not possible.
- In case the submitted data is incorrect or incomplete, we will send you an email asking to resubmit your data. If your application still does not fulfil the criteria required, the cashback claim will be rejected.

### **3. Applicable legislation**
